




Figure 1. Self Clamped Inductive Switching Current vs. Time in Clamp




Figure 3. Collector to Emitter On-State Voltage vs. Junction Temperature




Figure 5. Collector to Emitter On-State Voltage vs. Collector Current




Figure 2. Self Clamped Inductive Switching Current vs. Inductance




Figure 4. Collector to Emitter On-State Voltage vs. Junction Temperature




Figure 6. Collector to Emitter On-State Voltage vs. Collector Current




Figure 7. Collector to Emitter On-State Voltage vs. Collector Current




Figure 8. Transfer Characteristics




Figure 9. DC Collector Current vs. Case Temperature




Figure 10. Threshold Voltage vs. Junction Temperature




Figure 11. Leakage Current vs. Junction Temperature





Figure 12. Switching Time vs. Junction Temperature




Figure 15. Break down Voltage vs. Series Gate Resistance





Figure 16. IGBT Normalized Transient Thermal Impedance, Junction to Case

Figure 18.  $t_{ON}$  and  $t_{OFF}$  Switching Test Circuit




Figure 19. Energy Test Circuit




Figure 20. Energy Waveforms
